**STATEMENT OF ACCREDITATION:**

Alaska Christian College is accredited by the Association for Biblical Higher Education Commission on Accreditation (COA). The institution was last reviewed by the COA in February 2017. The next comprehensive team visit will be conducted in the spring of 2026, followed by a COA review for reaffirmation of accreditation in February 2027. The institution's current status expires February 28, 2027.

The institution was granted reaffirmation of accreditation at its last COA review on the basis that it evidences substantial compliance with ABHE's Institutional Accreditation Standards, including documentation of the appropriateness, rigor, and achievement of its stated student learning outcomes and all other Title IV eligibility requirements. In the COA's judgment, the institution had no significant deficiencies in satisfying the Institutional Accreditation Standards or the related Essential Elements within the Standards. The institution is currently in good standing with the ABHE Commission on Accreditation, and no sanctions (warning, probation, show cause why accreditation should be continued) are in effect.

Institutional accreditation applies to the institution as a whole and includes all educational programs offered by the institution.
